



CONCLUSION OF CAPITAL RAISING FROM OPTIONS

Beacon Minerals is pleased to announce that A\$ 2.30 Million has been raised from the fully underwritten conversion of the BCNOA options that expired 31 August 2010.

Existing option holders converted 220,862,109 options (96 %) of the total 229,949,110 on issue with the balance being placed with the underwriter. The support of our existing share and option holders is very much appreciated and encouraging as we continue to develop the Barlee Gold Project.

This additional funding will be allocated to further regional exploration on the Barlee Gold Project in order to build on the existing JORC inferred resource at Halleys East and Phil. Currently another drilling program is being planned for November.

The company remains in a strong position with the ability to fully fund exploration for the next year.
