DRILLING PROGRAM AT BARLEE GOLD PROSPECT

As a follow up to the successful completion of it's rights issue the company is pleased to announce that it has commenced site preparation for the planned drilling program at it's Barlee Gold Prospect, north of Southern Cross.

Recent interpretation of re-processed aeromagnetic data has identified a number of regional targets within the Barlee Gold Prospect. Selected priority target areas are currently being gridded with the drilling program anticipated to commence mid April. The planned drilling program includes **4,300 metres** of RC and aircore drilling and it's objectives include:

- To test the extensions of Halleys East and Phil Prospects where previous significant high grade, shallow gold intersections were obtained including :
 - **27m @ 36.4 g/t ,**
 - **11m @ 24.9 g/t ,**
 - **15m @ 11.5 g/t ,**
 - **19m @ 4.9 g/t ,**
 - **14m @ 3.7 g/t,**
 - **5m @ 26.6 g/t**

- To drill several priority regional targets where soil geochemistry and interpretation of aeromagnetic data has identified potential mineralized shear zones.

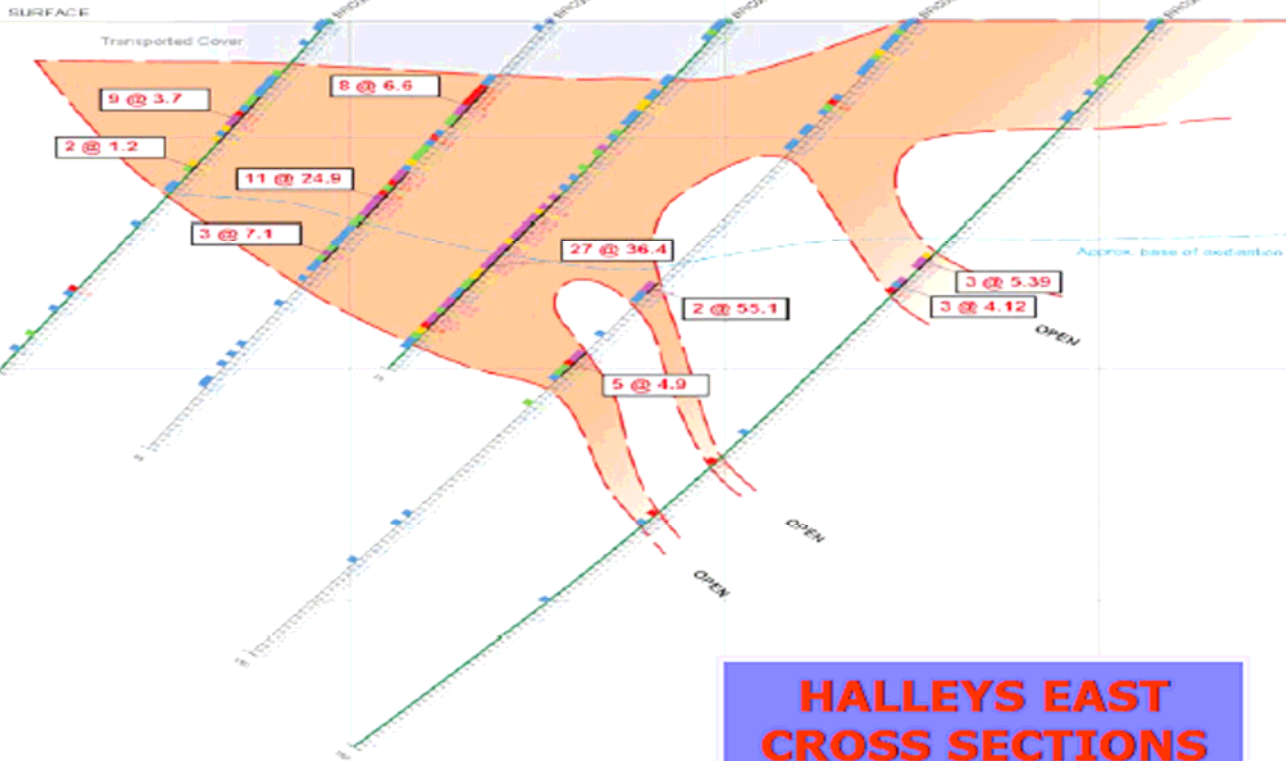
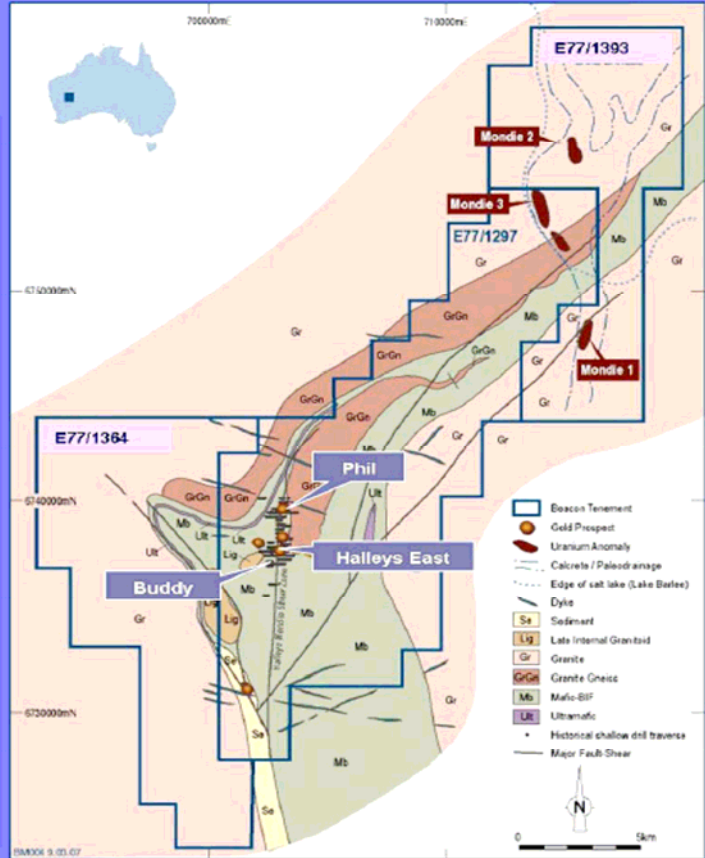

(25 m apart)**

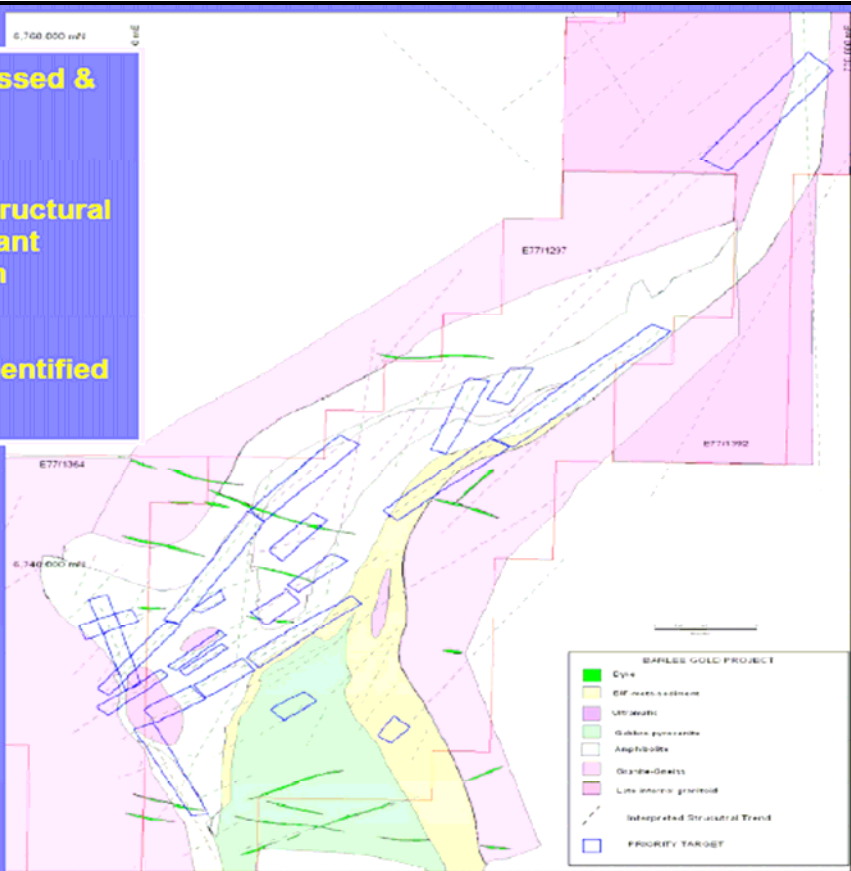
