\$7.54 M RAISED THROUGH EXERCISE OF OPTIONS

Beacon Minerals Limited (ASX: **BCN**) (“**Beacon**” or “**the Company**”) wishes to advise that \$7.54 million has been raised through the exercise of Listed Options (ASX: BCNOB).

As announced on 12 February 2021 Beacon will be paying an unfranked dividend totalling \$0.007 per share:

- Interim dividend of \$0.002 per share
- Special dividend of \$0.005 per share

The early conversion of the Listed Options will ensure that the options will be converted in time to be eligible for the \$0.007 dividend.

As announced on 12 February 2021 the Directors of the Company intend to exercise their Listed Options. The Directors hold 160,194,331 Listed Options, resulting in funds of \$4.0 million raised. To date the Directors have exercised 134,593,445 Listed Options, totalling \$3.34 million. The remaining Listed Options will be exercised in due course.

MD/Chairman Graham McGarry said:

“The Company has allowed over a month for Optionholders to exercise their options in time for the dividend. The response in the first week is very supportive of the direction of the Company.”
